

This document contains key information you should know about Series F Founders Units of the Algonquin Fixed Income 2.0 Fund (the “Fund”). **Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.**

**This Fund is an alternative mutual fund. It invests in asset classes and/or uses investment strategies that are not permitted for conventional mutual funds. The specific strategies that differentiate this Fund from conventional mutual funds include increased use of derivatives for hedging and non-hedging purposes; increased ability to sell securities short; and the ability to borrow cash to use for investment purposes. While these strategies will be used in accordance with the Fund’s investment objective and strategies, during certain market conditions they may accelerate the pace at which your investment decreases in value.**

Algonquin offered Series F Founders Units until the day that the Series reaches a net asset value of \$50 million (the “Founders Investment Period”). The Founders Investment Period has now closed, however, holders of Series F Founders Units may continue to purchase Series F Founders Units through pre-authorized contribution plans established before the end of the Founders Investment Period or through reinvested distributions.

### What does the fund invest in?

The investment objective of the Fund is to generate positive total returns over the long term and to preserve capital. The Fund will primarily invest in debt and income producing instruments of governments, corporations and financial institutions in the developed world as well as derivative contracts for investment or hedging purposes.

The Fund will invest primarily in fixed income securities and will focus on corporate and government debt. The Fund may also invest in convertible debt securities, fixed income securities of government agencies or of supranational agencies, floating rate securities, trusts, corporate bonds and loans, exchange traded funds, limited partnerships, and preferred shares. The Fund may hold a portion of its net assets in securities of other investment funds, including ETFs, in accordance with its investment objectives. The types of underlying funds held by the Fund will be selected with consideration for the underlying fund’s investment objectives and strategies, past performance and operational efficiencies.

The Fund has received an exemption that allows it to short sell up to 300% of the Fund’s net asset value in “government securities”. The maximum aggregate exposure to all sources of leverage is 300% of the Fund’s net asset value.

The charts below give a snapshot of the Fund’s investments on October 25, 2021. The Fund’s investments will change.

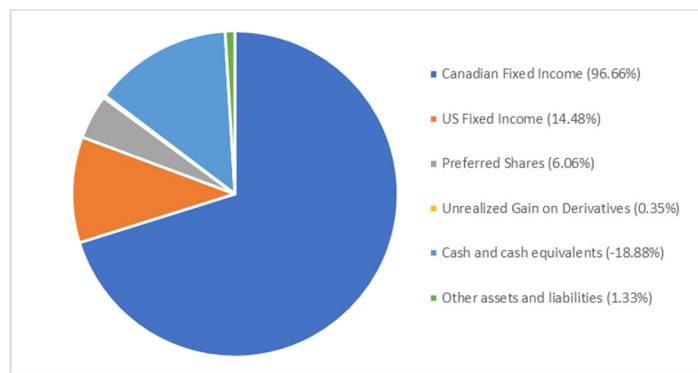

## How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk Rating

**Algonquin has rated the volatility of this Fund as low to medium.**

Because this is a new fund, the risk rating is only an estimate by Algonquin. Generally, the rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

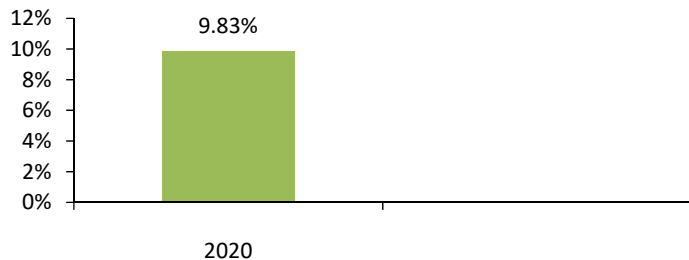
Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the money you invest.

## How has the Fund performed?

This section tells you how Series F Founders Units of the Fund have performed since its inception. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

### Year-by-year returns

This chart shows how the Series F Founders Units of the Fund have performed over its first full calendar year of existence. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



### Best and worst 3-month returns

This table shows the best and worst returns for Series F Founders Units of the Fund in a 3-month period over the past year. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

### Average returns

A person who invested \$1,000 in Series F Founders Units of the Fund since its inception now has \$1,066.51. This works out to an annual compound return of 6.65%.

## Who is this Fund for?

Investors who:

- Want to gain exposure to a diversified portfolio of primarily investment grade fixed-income investments;
- Want to gain exposure to alternative investment strategies to diversify the fixed income portion of your investment portfolio;
- Plan to invest for the medium term or longer; and
- Are comfortable with a low to medium risk level.

## A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund outside a registered plan, fund distributions are included in your income for tax purposes, whether you get

them in cash or have them reinvested. If you hold your fund inside a registered plan, you will include fund distributions and other amounts you withdraw from your registered plan in your income for tax purposes. Different rules apply for Tax-Free Savings Accounts.

## How much does this cost?

The following table shows the fees and expenses you could pay to buy, own and sell Series F Founders Units of the Fund.

The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### Sales charges

There are no sales charges for the purchase of Series F Founders Units of the Fund.

### Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

The Fund's expenses are made up of the management fee, operating expenses and trading costs. The Fund's Series F Founders annual management fee is 0.50% of the Series F Founders Units' net asset value.

As of July 31, 2021, the Fund's expenses were 1.50% of its value. This equals \$15.00 for every \$1,000 invested.

## ANNUAL RATE (AS A % OF THE FUND'S VALUE)

### Management expense ratio (MER)

This is the total of the Series F Founders Units' management fee and Series F Founders Units' share of the Fund's operating expenses. Algonquin waived some of the Fund's expenses. If it had not done so, the MER would have been higher. 0.80%

### Trading expense ratio (TER)

These are the Fund's trading costs. 0.70%

### More about the trailing commission

There is no trailing commission payable to your representative's firm for Series F Founders Units of the Fund.

### Other fees

You may have to pay other fees when you buy, hold or sell Units of the Fund.

Fee	What you pay
Short-term trading fee	2% of the value of Units you sell within 30 days of buying them. This fee goes to the Fund.
Redesignation Fee	Up to 2% of the value of the Units you redesignate. This fee goes to your representative.
Series F Founders Fee for service	Series F Founders Units are available to you if you have a fee-based or wrap account for which you pay a fee directly to your representative's firm.

## What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase order within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
